

School Consent Form

The new Data Protection Act has changed the way schools process Pupil Data. We are now required to clearly state what our legal basis is for processing personal data about your child. For most school activities we believe our basis is

"processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller"

In other words, the Department of Education has given us the authority to provide Education Services to your child.

As part of our school activities, we may occasionally take photographs or video of the children that attend our school. These could be individually or in groups. We use these to record achievement and to celebrate those achievements within the school.

However, we also may wish to use these images in many other ways:

- school displays
- school publicity material
- school website
- school newsletter
- local or national media
- Facebook page
- Twitter account

To comply with the Data Protection Act 2018, we need your permission before we can photograph or make any recordings of your child to use in this way.

Please sign, complete the form attached, and return to Yeading Infant and Nursery School office. If you ever need to withdraw consent for any reason, please do so in writing to INSERT NAME.

Terms and Conditions

1. This form is valid for the period your child attends this school. Images of your child will not be used after this time.
2. Please write to the school if you wish to withdraw consent at any time.
3. The images we take will be of activities that show the school and children in a positive light.
4. Embarrassing or distressing images will not be used. The images will not be associated with negative or sensitive issues.
5. We may use group or class photographs or footage with very general labels e.g. 'science lesson'.
6. If we use photographs of individual pupils, we will not use the name of that child in the accompanying text or photo caption. If we name a pupil in the text, we will not use a photograph of that child to accompany the article.
7. If a child has won an award and the parent would like the name of their child to accompany their picture we will obtain explicit permission from the parent before using the image.
8. We will only use images of pupils who are suitably dressed.
9. We will make every effort to ensure that we do not allow images to be taken of any children for whom we do not have permission or who are 'at risk' or disallowed from having their photographs taken for legal or social reasons.
10. We will take all reasonable measures to ensure the images are used solely for the purposes for which they are intended. However, we cannot guarantee this and take no responsibility for the way images are used by other websites or publishers or for any consequences arising from publication.

Please note that websites can be viewed throughout the world and not just in the United Kingdom where UK law applies. In giving your consent, you understand that images may be used in printed and electronic form.

Once your child leaves the school, this form will be considered invalid and if we would like to continue to use your child's image (e.g. in publicity material) we will obtain renewed, written consent.
